Delivery Period: All the vehicle duly fabricated as per the specification and terms agree upon has be to be delivered Within 30 days of fulfilling the terms to start the work including receipt of vehicle and payment of advance. 1) <u>Free Replacement NBJK</u> reserves the right to call re-fabrication or reimbursement in the event of the following:-

- a) Poor quality of material used in fabrication
- b) Loss/ Damage or deterioration of any material used in fabrication within the warranty life.
- c) Equipment provided or material used in fabrication fails to perform or meet requirements of the specification to the satisfaction of NBJK.
- 2) Warranty: Warranty one year for internal fabrication work and at vehicle site service available for minor repairs related to cabinets, screws, etc. Major repair services like internal electrical work, side walls and roof panelling, flooring will be provided at the Factory site. All goods supplied must cover a warranty for one year, against manufacturing defects, from the date of supply. Electrical consumables and accessories should be covered under warranty.
- 3) **Labelling:** All labels should be printed in English Language.
- 4) <u>Payment</u>
 - a) All payment will be made by way of bank transfer within 15 days from the date of fulfilling all the term of payment as per the agreement signed for Fabrication and raising of correct invoice whichever is later. Payment shall be done as per the payment terms agreed upon.
 - b) A bank guarantee would be issued by supplier to the buyer for the advance amount for period from the date of advance till the date of acceptance of delivery.
 - c) Currency would be in Indian Rupees.
 - d) All bank charges incurred shall be borne by the supplier.
- 5) <u>Liquidated Damages</u> Delivery of fabricated vehicles shall not be later than the time specified in Work Order. The penalty provision becomes enforceable for delays in delivery. A penalty ranging from 1% to 5% on the amount of work order will be imposed, with calculations based on specific time frames: a delay of 1-7 days will incur a 1% penalty, 7-14 days will result in a 2% penalty, and so forth.
- 6) Arbitration
 - a) If any dispute or difference or claim shall arise between the parties as to any point in any agreement or contract arising of the invitation to tender, or as to any matter or thing of whatsoever nature there under or in connection therewith, then either party shall within 30 days give to the other, notice in writing of such dispute. Such dispute shall be referred to a single arbitrator in case the party agrees upon one, otherwise to three arbitrators, one to be appointed by each party and the third arbitrator by the other two arbitrators. If either party shall refuse or neglect to appoint an arbitrator as aforesaid shall proceed to hear and determine the matter as if they were and arbitrator appointed by both parties to the dispute.
 - b) The decision or award of the arbitrators (as the case may be) shall be final and bidding upon the parties and shall be a prerequisite to any proceedings in Court of Law at Hazaribag.

- c) The arbitrator or arbitrators shall determine by whom and in what manner, the cost of arbitrator (or any party thereof) shall be borne or paid.
- d) The arbitration shall be governed by the Indian Arbitration Act.
- 7) **Law:** Indian law shall govern the validity, performance and enforcement of this contract.

Installation, Commissioning and Acceptance Schedule: All the vehicle duly fabricated as per the specification and terms agree upon has be to be delivered Within 30 days of fulfilling the terms to start the work including receipt of vehicle and payment of advance. The delivery has to be done at Nav Bharat Jagriti Kendra's Coordination office Vill- Amrit Nagar, Post Rolla, Dist- Hazaribag, (Jharkhand) PIN Code- 825303.

- a. 100% fabricated vehicles will be subject to physical inspection by the technical team of the purchaser to ascertain that they conform to the samples/ specifications as laid down in the supply order. In case the above item is not found to be conforming to the laid down samples/ specifications, the authorized representative of the firm will be intimidated by the buyer and defective stores if any will be removed and replaced by the supplier at his own expense within a period of 15 days of inspection. In case of any dispute, decision of the purchaser will be final.
- b. The material used should be of latest manufacture conforming to the current product standard having 100 % defined life at the time of delivery. The manufacturing date of the items used should preferably be not older than 3 months and in no case shall be older than 9 months as on the date of supply.

1) <u>Warranty:</u> The fabricator warrants that the fabrication work shall be of good quality and shall have no defect in fabrication, shall meet all the requirement of the specifications and shall in all aspects be suited for the purposes intended, the warranty provided by the supplier shall be relied upon strictly enforced by NBJK.

2) Warranty against benefits

a) The supplier warrants that he /it has not given or promised to give any money or gift to any officer or employee of NBJK thereof with the intent or objective of securing the contract.b) Any violation of this warranty shall be sufficient grounds for cancellation or revocation of the contract without any claim against NBJK.

3) **Local Agent** Suppliers acting through local agents should indicate names and addresses and telephone/ E- mail of the agent in India.

4) <u>Assignment Supplier</u> shall not without the written consent of the NBJK assign his contract or part thereof to another.

5) **<u>Stamp Duty</u>**: The supplier should pay any stamp duties payable under the Stamps Act in respect of contract.

6) **Notice:** All notices given in respect of this contract shall be deemed to be sufficiently given if sent by the registered post or courier.

PART IV- EVALUATION CRITERIA & PRICE BID ISSUES

- 1. Evaluation criteria: The broad guidelines for Evaluation of Bids will be as follows:
 - a) Only those bids will be evaluated which are found to be fulfilling all the eligibility and qualifying requirement of the RFP.
 - b) The technical specifications already forwarded by the bidders will be evaluated by the buyer with reference to the technical characteristics of the fabrication work for which quotes are submitted.
 - c) The evaluation criteria will generally be based on twin conditions of lowest bids and the quality criteria.
 - d) The bidders are required to spell out the rates of GST and other Taxes, Cess and duties etc. in unambiguous terms; otherwise their offers will be loaded with the maximum rates of duties and taxes for the purpose of comparison of prices. If reimbursement of GST and other Taxes, Cess and duties is intended as extra over the quoted prices, the Bidder must specifically mention so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duties will be entertained after opening the tenders. If the bidder chooses to quote a price inclusive of such duty so included is firm and final he should clearly indicate the rate of such duty and quantum of GST and other Taxes, Cess and duties included in the price. Failure to do so may result in ignoring of such offers summarily. If a bidder is exempted from payment of GST and other Taxes, Cess and duties up to any values they should clearly state that NO GST and other Taxes, Cess and duties will be charged by them up to the limit of exemption which they may have. If any concession is available in regard to the rate/ Quantum of GST and other Taxes, Cess and duties, it should be brought out clearly. Stipulations like GST and other Taxes, Cess and duties was presently not applicable but the same will be charged if it becomes levy able later on, will not be accepted unless in such cases it is clearly stated by a bidder that GST and other Taxes, Cess and duties will not be charged by him even if the same becomes applicable later on. In respect of the bidders who fail to comply
